**COVID-19: HEALTH PROTOCOL POUR LES ORGANISATEURS -
CDI3* NICE [AUTUMN 2020]**

Le protocole sanitaire établi pour la pratique des sports équestres d'extérieur est basé sur la charte et la réglementation existante, les nouvelles exigences gouvernementales en matière de distance de sécurité sanitaire, de comportements et toutes les bonnes pratiques, procédures et méthodologies issues de sources faisant autorité (Ministères, organismes de santé et de sécurité, Fédération Française d'Equitation, Fédération Internationale d'Equitation, SHF, etc.). Ce référentiel respecte le guide sanitaire COVID-19 établi en concertation entre la fédération des sports équestres et les ministères de tutelle.

Il est basé sur ces différents points :

1. Respecter les recommandations des autorités sanitaires face au COVID-19,
2. Communiquer sur les mesures préventives à mettre en place face aux risques de transmission du COVID-19,
3. Former les organisateurs aux gestes barrières et au référentiel sanitaire et mettre à leur disposition des équipements de protection,
4. Mettre en place une signalisation incitant à la distanciation sociale d'1,50 m dans les lieux d'accueil,
5. Offrir du gel hydroalcoolique aux compétiteurs et aux organisateurs dans les espaces communs,
6. Renforcer le nettoyage et la désinfection des parties communes avec des produits de nettoyage-désinfection deux fois par jour et assurer une aération des sanitaires collectifs
 - Dès l'entrée dans le sanitaire, il est demandé de se laver les mains avec de l'eau et du savon ou du gel hydroalcoolique.
 - Le nettoyage et la désinfection des parties communes sont renforcés ainsi que des sanitaires collectifs.
 - Il est recommandé de ne pas stationner dans les couloirs des sanitaires et de respecter les règles de distance de sécurité sanitaire.
7. Établir et appliquer des consignes d'accès et de sécurité sanitaire renforcées et spécifiques aux zones communes (aires de trotting et de grooming) en accord avec les recommandations des autorités sanitaires,
8. Déployer le plan de maîtrise sanitaire dans tous les lieux de restauration conformément aux recommandations des autorités sanitaires.
9. Appliquer le protocole de gestion du risque en cas de suspicion de contagion au COVID-19 chez un compétiteur ou un organisateur en conformité avec les recommandations des autorités sanitaires.

10. Le port du masque rend difficile la pratique d'un grand nombre de disciplines sportives. Il se justifie cependant dans certaines situations où les mesures de distance de sécurité sanitaire ne pourraient pas être strictement respectées. Il est recommandé aux juges, vétérinaires et officiels de la course de le respecter.
11. Le Club Hippique de Nice (06) est conforme aux exigences de sécurité sanitaire, technique et d'organisation de réunion publique du ministère de l'agriculture (puisque'il est dénommé « ERP »). (FICHE DE REPRISE DES ACTIVITÉS EQUESTRES - PÉRIODE A COMPTER DU 22 JUIN 2020 : « L'organisation des compétitions équestres au sein d'un ERP est de nouveau possible depuis le 22 juin dernier. (Aucun événement réunissant plus de 5 000 personnes ne peut se dérouler jusqu'au 31 août 2020 sur tout le territoire. »)

COVID-19: HEALTH PROTOCOL POUR LES COMPETITEURS ET ACCOMPAGNANTS - CDI3* NICE [AUTUMN 2020]

En arrivant sur le concours, toute personne doit avoir dans son véhicule :

- Masques pour tous les participants
- Gel hydro alcoolique
- Tout son matériel (échange interdit sur le concours)

Pendant tout le séjour sur le site :

- Se garer selon les recommandations des organisateurs, à distance les uns des autres
- Prendre ses dispositions pour éviter de croiser d'autres chevaux / cavaliers lors de la préparation
- Respecter 1,50m de distanciation sociale dans les zones de rencontre : paddocks, douches, tribunes, restauration, parkings, zones d'assistance
- Le port du masque reste très recommandé dans toutes les zones où la distanciation de 1,50m ne pourra pas être respectée
- Respecter les gestes sanitaires et les mesures barrières

Non-respect des règles :

- Toute personne ne respectant pas ces mesures sanitaires pourra être expulsé du terrain de concours.

**COVID-19: HEALTH PROTOCOL FOR ORGANIZERS -
CDI3* NICE [AUTUMN 2020]**

The health protocol established for the practice of outdoor equestrian sports is based on the existing charter and regulations, the new government requirements in terms of health safety distance, behavior and all good practices, procedures and methodologies from sources making authority (Ministries, health and safety organizations, Fédération Française d'Equitation, Fédération Equestre Internationale, SHF, etc.). This standard complies with the COVID-19 health guide established in consultation between the equestrian sports federation and the responsible ministries.

It is based on these different points:

1. Respect the recommendations of the health authorities in the face of COVID-19,
2. Communicate on the preventive measures to be put in place in the face of the risk of COVID-19 transmission,
3. Train all organizational staff in barrier gestures and health standards and provide them with protective equipment,
4. Put in place 1.5 m signage encouraging social distancing in reception areas,
5. Offer hydroalcoholic gel to competitors and organizers in collective spaces,
6. Reinforce the cleaning and disinfection of common areas with cleaning-disinfection products twice a day and ensure ventilation of collective sanitary facilities.
 - As soon as entering the sanitary facilities, it is asked to wash your hands with water and soap or hydroalcoholic gel.
 - The cleaning and disinfection of common areas are reinforced as well as collective sanitary facilities.
 - It is recommended not to stay in the corridors of the sanitary facilities and to respect the sanitary safety distance rules.
7. Establish and apply reinforced access and health security instructions specific to collective areas (trotting and grooming areas) in accordance with the recommendations of the health authorities,
8. Apply the health control plan in all catering establishments in accordance with the recommendations of the health authorities.
9. Apply the risk management protocol in the event of a suspected COVID-19 contagion at a competitor or an organizer in accordance with the recommendations of the health authorities.

10. Wearing a mask makes it difficult to practice a large number of sports disciplines. It is however justified in certain situations where the sanitary safety distance measures could not be strictly observed. It is recommended that judges, veterinarians and event officials respect it.
11. The Club Hippique de Nice (06) complies with the health, technical and public meeting organization requirements of the Ministry of Agriculture (since it is referred to as "ERP"). (SHEET FOR THE RESUMPTION OF EQUESTRIAN ACTIVITIES - PERIOD STARTING FROM JUNE 22, 2020: « *The organization of equestrian competitions within an ERP has been possible again since June 22. (No event bringing together more than 5,000 people can take place until August 31, 2020 throughout the territory (France). »*)

COVID-19: HEALTH PROTOCOL FOR LES COMPETITORS AND ACCOMPANIENTS - CDI3* NICE [AUTUMN 2020]

When arriving at the competition, everyone must have in their vehicle:

- Masks for all participants
- Hydro alcoholic gel
- All necessary material (exchange prohibited on the competition)

During all the stay on the competition site:

- Park as recommended by the organizers, at a distance from each other
- Pay attention to avoid crossing other horses / riders during the preparation
- Respect 1.50m of social distancing in meeting areas: paddocks, showers, stands, catering, car parks, assistance areas
- Wearing a mask remains highly recommended in all areas where the distance of 1.50m cannot be respected
- Respect sanitary procedures and barrier measures

Non-compliance with the rules:

Anyone not respecting these sanitary measures may be forced out from the competition area.

III. THE FEI CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

4. PONIES

FEI Veterinary Regulations, Chapter IX and Annex IX: For all Pony Events, Ponies must be available for Pony Measurement if requested by the FEI.

5. INJURY SURVEILLANCE

FEI Veterinary Regulations, Chapter VIII: Horses participating in FEI Events are subject to injury surveillance protocols; and in the event of fatality, a post mortem examination.

6. TRANSPORT OF HORSES

Horses must be fit to travel and be transported in suitable vehicles. Any government requirements for disease testing and control must be requested well in advance, to ensure that the horse is in compliance by the time of arrival at the border of the country where the Event is taking place. Athletes, or their representatives, have the responsibility to comply with national legislation in both their country of origin and the host nation of the Event. Where necessary athletes must contact local government authorities or veterinary advisors for information regarding animal health requirements and transport legislation. Within the European Union (EU), this includes EU Council Regulation (EC) No 1/2005

concerning the protection of animals during transport within the Member States of the EU.

7. VENUE ARRIVAL INFORMATION & FITNESS TO COMPETE

7.1 PASSPORTS. FEI General Regulations Article 137

For all issues relating to FEI Horse Passports/FEI Recognition Cards please contact your National Federation.

All Horses competing at FEI Events must be registered with the FEI.

FEI Passports or FEI Recognition Cards (for those Horses with a national passport approved by the FEI) are compulsory for FEI Events.

NB: Horses entered in CIMs in their country of residence are not required to have an FEI Passport or FEI Recognition Card but must be properly registered with the FEI and identifiable (GRs 137.2).

Athletes who do not present a Horse's Passport and/or Recognition Card, or one that is not correctly validated or fail to meet other passport requirements will be **subject to Sanctions in accordance with Annex VI of the FEI Veterinary Regulations** and may not be allowed to compete.

NB for Horses permanently resident in a Member State of the European Union: all Horses must have a national EU passport in compliance with EU Regulations to which a FEI Recognition card is applied. The exception to this being Horses in possession of an FEI passport which has been continually revalidated without interruption.

7.2 VACCINATIONS - EQUINE INFLUENZA. FEI Veterinary Regulations Article 1003

Horses competing at FEI Events must comply with the requirements for Equine Influenza vaccination in accordance with the Veterinary Regulations and as summarised below.

All FEI registered Horses intending to compete at FEI Events (including CIMs) must be vaccinated against Equine Influenza in accordance with these VRs. The exception being if the applicable domestic legislation prevents the use of Equine Influenza vaccines within the relevant territory

7.3 EXAMINATION ON ARRIVAL. FEI Veterinary Regulations Article 1031

On arrival at an Event venue, all Horses must undergo an examination by a veterinarian to confirm their identification from their passport and micro-chip ID (where present), their vaccination status and general health. To protect all horses attending events, any Horse with a questionable health status concerning vaccination, disease or other concerns, must be stabled within the isolation facilities provided by the Organising Committee pending a decision on entering the venue.

7.4 HORSE INSPECTIONS. FEI Veterinary Regulations Articles 1034-1042

All Horses will be assessed for their fitness to compete during the Horse Inspection. Any Horse demonstrating questionable fitness may be referred to the Holding Box for further veterinary examination. Horses not deemed fit to compete by the Inspection Panel will not be permitted to compete.

7.5 LIMB SENSITIVITY EXAMINATION. FEI Veterinary Regulations Articles 1048-1053

All Horses are subject to examination under the protocol for abnormal limb sensitivity throughout the period of an Event. For Jumping that includes, but is not limited to, between rounds and before the Jump Off. For Endurance that includes, but is not limited to, pre-ride, during the ride and after the ride. Horses may be examined once or on multiple occasions during the Period of an Event. Horses may be selected for examination under the protocol randomly or they may be targeted. All Horses selected to be tested must submit promptly to the examination or are subject to immediate disqualification. There is no obligation to examine any specific number of Horses at an Event.

8. EQUINE ANTI-DOPING AND CONTROLLED MEDICATION PROGRAMME (EADCMP). FEI Regulations, Chapter VII

8.1 SAMPLING. FEI Veterinary Regulations Chapter VII

All horses competing at FEI Events may be subject to sampling for the presence of Prohibited Substances in accordance with the Anti-Doping and Controlled Medication Regulations (EADCMRs). Horses may be selected for sampling in accordance with obligatory testing, targeted or random sampling procedures. Refer to FEI Financial Charges for details of fees relating to Equine and Human Anti-Doping program (EADCMP), which OCs/NFs have the right to charge to the athlete (applicable for all FEI events worldwide).

8.2 ELECTIVE TESTING. FEI Veterinary Regulations Article 1058

Elective Testing may be carried out prior to an Event to check for the presence of Prohibited Substances. Please refer to <https://inside.fei.org/fei/cleansport/horses> for information and details.

XIII. HUMAN ANTI-DOPING

Athletes can be tested at any FEI Event, by the FEI or by other Anti-Doping Organisations with Testing jurisdiction. Organisers will have the responsibility to provide facilities and staff/volunteers to facilitate such Testing if requested by the FEI as outlined in article 22.3 of the FEIs' Anti-doping Rules for Human Athletes (ADRHA).

XIV. ADDITIONAL INFORMATION

1. THE FEI POLICY FOR ENHANCED COMPETITION SAFETY DURING THE COVID-19 PANDEMIC

The FEI Policy for Enhanced Competition Safety during the Covid-19 Pandemic ("Policy") (<https://inside.fei.org/fei/covid-19/return-to-play/policy-tools>) is mandatory and applies for any FEI Event taking place **as of 1 July 2020**. The Policy has been developed based on currently accepted best practices by the WHO and US Center for Disease Control (CDC) and will be continually reviewed and updated as more information becomes available. It is not intended to replace the applicable guidance and policies from domestic government and health authorities, but to supplement their recommendations with sport specific considerations.

The OC shall submit the risk assessment and mitigation plan (including name and contact details of the person in charge) to the FEI as an annex to the Event Schedule, **at the latest ten (10) working days before the event's deadline for Definite Entries.**

Events for which the FEI has not received the documented risk assessment and mitigation measures plan in accordance with article 2.1.g) of the Policy **will be removed from the FEI calendar** in accordance with Article 112.3 of the FEI General Regulations.

ASSUMPTION OF RISK / WAIVER OF LIABILITY

In consideration of being allowed to participate in the Event and related activities, all Participants (as defined in the Policy) acknowledge, appreciate, and agree that:

1. Participation includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. The Participants knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the OC or others, and assume full responsibility for their participation; and,

3. The Participants willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, a Participant observes any unusual or significant hazard during his/her presence or participation, the Participant will remove himself/herself from participation and bring such to the attention of the nearest official immediately; and,
4. The Participants, for themselves and on behalf of their heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THE OC AND THE FEI, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

The Participants confirm to have read this release of liability and assumption of risk agreement, fully understand its terms, understand that they have given up substantial rights.

2. INSURANCES AND NATIONAL REQUIREMENTS

Equestrian sports involve inherent dangerous risks. To the greatest extent permitted by law, the FEI and the FEI Event Organiser shall NOT be liable for any damages relating to loss of property or injury of any kind to Athletes, Owners, Support Personnel or Horses at or in connection with an FEI Event and the FEI expressly excludes all such liability.

2.1 ATHLETES, OWNERS AND SUPPORT PERSONNEL

2.1.1 Personal Accident and Health Insurance

It is your responsibility as an Athlete/Owner/ Support Personnel to ensure that you have adequate personal accident insurance in place to cover your participation at FEI Events and in particular to insure against any personal injury or medical expenses arising from an accident, injury or illness which may occur at a FEI Event.

You should check with your National Federation to confirm if your National Federation's insurance policy (if any) covers personal accidents and/or illnesses which may occur when you are attending at/participating in FEI Events.

If your National Federation does not have a personal accident/health insurance policy or if the National Federation's insurance policy does not cover personal accident or health claims, then you should obtain your own personal accident and health insurance policy to cover your attendance/participation at FEI Events.

2.1.2 Personal Property Insurance

You should also ensure that you are insured against property loss, theft or damage which may occur at an FEI Event.

Again, the advice is to check with your National Federation to confirm if they have an insurance policy in place which would cover you in case of such property loss, theft or damage. If not, then you should obtain your own personal property insurance to cover such situations.

2.1.3 Press Equipment

Press equipment and other items left in the Press workroom, Press lockers, the Press Tribune or anywhere on the showgrounds are left entirely at the owner's risk. The Organising Committee does not accept any responsibility for any loss or damage to such equipment or items. Members of the Press are advised not to leave any equipment or personal items unattended.

2.2 ATHLETES AND OWNERS

2.2.1 Third Party Liability Insurance

As an Athlete/Owner you are personally responsible for damages to third parties caused by you, your employees, Support Personnel, your agents or your Horses. You are, therefore, strongly advised to take out third-party liability insurance providing full coverage in relation to FEI Events at home and abroad, and to keep the policy up to date.

The FEI and the Organiser will NOT be responsible for any damage caused to third parties by you, your employees, Support Personnel, your agents or your Horses.

2.2.2 Additional Liability Information

As an Owner you should ensure that your Horses are adequately insured against any injuries or illnesses they may sustain while participating at a FEI Event.

In the event of any discussion concerning the interpretation of the schedule (in translated languages), the English version will be decisive.

5. MODIFICATION TO SCHEDULE

In exceptional circumstances, together with the Approval of the Chefs d'Equipe, host NF delegate, if any, and the Ground Jury, the OC may change the schedule in order to clarify any matters arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all Athletes and Officials

as soon as possible and they must be reported to the FEI by the Foreign Judge.

6.ADDITIONAL INFORMATION FROM THE ORGANISER

Art 109.13 GRs: All dogs must be leashed and affixed to a human or stationary object. Violation of this rule will incur a fine of CHF 100 per offence and, in case of a repeated offence at the Event, may lead to exclusion from the Venue

DEDUCTIONS FROM PRIZE MONEY AT COMPETITIONS:

Full details of any deductions from prize money must be outlined in the schedule. This includes government taxes. If it is necessary for Organisers to deduct such taxes, they must provide participants with an official form indicating the amount of tax deducted.

The tax form must be provided to the athletes upon arrival and returned to the Organiser prior to departing.

The settlement of amounts owed by the organising committee for foreign riders will be based forward Art.130.2. Gains will be distributed, at the latest, at the end of the last race of the competition.

The Art. 30.II of the Finance Act for 1990, amending Ar. 182.B in January 1990, exposes persons domiciled outside France for artistic or athletic, supplied or used in France, restraint the specific source of 15% subject to the provisions of the international Conventions.

To be exempted from it, rider should provide a certificate proving a payment of its taxes in France. Without it, this taxes must be paid

The OC could also pay prize money by bank transfer. An Iban / Particulars of bank account will be necessary

IMPORTANT

The total amount of prize money shown for each Competition in the schedule must be distributed. (FEI General Regulations articles 127 and 128)
